Each booth space will have a maximum size of 10'X10' and will be located on the Front Slab. If you desire a larger space, you may purchase multiple booths to accommodate your needs. Fee includes use of electricity, as available. Vendors must supply their own tables, coverings, and 100' extension cord. All spaces are available on a first come, first serve basis and booths will be arranged based on the product being sold and in the order applications are received. If you will be vending from a trailer, your rate will be made according to the amount of space your trailer requires. Please contact the numbers listed below for pricing information.

Your booth fee will include 2 vendor passes for booth workers and also a parking pass.
